Meeting began 9:00 am and was conducted via ZOOM.

April 5 Member Meeting Program--"Preparing for Life Transitions"--Via Zoom

Ernie Pressman said he would send a letter to program guest presenter Kelley Rogers-Johnson, CEO of Senior One Source, a senior life transitions counseling organization, to ask her to first give a ten-minute overview of their organization. His letter would also explain that the nature of the remainder of the program would consist of (1) Kelley and local Senior One Source representative, Jamie Jablonski, participating in a question and answer session with attendees and (2) a time for attendees to tell of their personal life transition experiences. Martha Greaney said that meeting reminders would go out to members on March 29 and April 4.

Treasurer's Report

Treasurer Martha Greaney reported that dues payments had been received from six members. Ernie Pressman asked that members be reminded to pay their 2022 dues.

Outreach

Manny Balesteri said he had identified three publication for listing LCAP member meetings and organizational information: the Eugene Weekly, Daily Emerald (U of O) and The Chronicle paper (Creswell and Cottage Grove). Board members talked about various program alternatives for that meeting, which would be further discussed at the next Board meeting if necessary.
