Jill suggested, as a backup program if needed, a panel of at least three people to present social services resources available in the community to seniors—Diane Bishop, Beth Naylor and Jill Hubbard. Ernie asked Jill to determine if these three people would be available for the February member meeting if the legislative session program is confirmed for the December meeting.

Ernie thanked Jill for her Board service. Discussion followed regarding trying to encourage other members to volunteer for the Board.

Ernie also said a decision would be made later to determine if local pandemic conditions would enable the December meeting to be held in person at Campbell Center.
